RULES & REGULATIONS

1. Booths are not provided. Space accommodates a 10x10 canopy. Fee \$35.00
 If you need an 18x20 space, size of two cars parked side by side, Fee \$70.00
2. You may start setting up at 7:30am. Booths will be open from 11am to 4pm.
3. We will only accept vendors displaying & selling wholesome, family suitable items.
4. After booth set-up, your vehicle must be moved out of parking lot.
5. **NO VEHICLES ALLOWED IN BOOTH AREAS DURING CRAFT SHOW. PARKING AVAILABLE AT BONITA SHOPPING CENTER PARKING LOTS, MOST STORES CLOSED ON SUNDAY.**
6. Booth area must be left clean, this is the responsibility of the participant.
7. Hand-made Crafts only, no imported/commercial items to be displayed. Must be suitable for our family event. The Committee shall be the sole judge as to suitability. Please submit a photo of your crafts, it will be returned.
8. Please attach a copy of your seller's permit and liability insurance (copy of your Business or Homeowner's liability page will be accepted, kept confidential.)
9. Reservation fee is non-refundable. There is no "bad weather" refund.
10. One craft business per booth space, please.

Business or certified checks or money orders will be accepted until event deadline-April 1, 2010. Make business checks, certified checks or money orders for \$35.00 payable to BBPA. Include self-addressed stamped envelope to help our committee with postage costs. "Insufficient Fund" check fee \$40.00. Mail Complete packet to: BBPA, PO Box 284, Bonita, CA 91908. You will receive an event map with your booth space number 1-2 weeks before event.
