Who Qualifies?

A senior graduating from Bonita Vista High School and going to a 2 or 4 year college.

OR...

A son or daughter of a current Bonita Business & Professional Association member who is graduating from high school and furthering their education.

OR...

A son or daughter of a current Bonita Business & Professional Association member who is continuing their education at an accredited college or university.

How Many Scholarships will be awarded?

Up to five scholarships of **\$1000** each for local area students who meet the qualifications and are selected from the pool of applicants.

On what basis will the applications be judged?

Well-rounded students with a record of past achievement and future potential are encouraged to apply. Applicants must be a graduating senior from Bonita Vista High School residing in Bonita, CA (zip code 91902) or Chula Vista, CA (zip codes 91910 or 91913), a United States citizen, and be planning to attend an accredited two-year college or four-year university in the United States. Students must have a minimum 2.50 GPA on a 4.0 scale.

Where does the money come from?

The Bonita Business & Professional Association (BBPA) has the honor of distributing funds from the C.B. & Ardel Hamilton Trust. This trust was set up in 1988 as a legacy for graduating seniors as described in the qualification statement.

What are the rules?

1. Deadline: February 24, 2012
2. The application must consist only of the following six pages and a **sealed** copy of your transcripts. Please **do not** submit any other documents or folders.
