### You are invited to participate in the 38th Annual "WILD WEST" BONITAFEST RULES AND REGULATIONS

1. Booths are not provided—space sizes are 18'x20' (2 parking spaces) or 9'x20'(1 parking space).
2. **ELECTRICITY AND WATER ARE NOT AVAILABLE.** You must make your own arrangements. **NO GENERATORS**
3. You may **begin set up at 6:00 AM** Saturday. Booths will **open at 9:00 AM** and **close at 5:00 PM**
4. Your space and fee will be forfeited if you arrive after 8:30 AM
5. Immediately after booth set up vehicles **must be** removed from parking lot. Shuttle buses will not be available at designated parking areas. Parking: Bonita Valley Community Church 4744 Bonita Road (dirt lot) east of Otay Lakes Road. West end of event, parking available at Kaiser Permanente Parking Lot – Bonita Rd at Willow.
6. **NO VEHICLES ARE ALLOWED IN BOOTH AREAS AFTER 9:00 AM OR BEFORE 5:00 PM, NO EXCEPTIONS!**
7. All booths and displays must furnish trash receptacles at their space and empty into large bins which will be provided in each shopping center. **At closing, booth space cleanup is the responsibility of the participant.**
8. Materials and merchandise to be displayed must be suitable for family viewing. The Bonitafest Committee shall be the sole judge as to suitability. **PLEASE SUBMIT PHOTOS** of merchandise to be sold if this is your first year.
9. **ALL NON PROFIT FOOD BOOTHS MUST COMPLY WITH THE HEALTH DEPARTMENT PERMIT AND LICENSING REGULATIONS.** This is the sole responsibility of the participant. Health Dept. requirements available.
10. Reservation fees are non-refundable. There is no "bad weather" refund
11. **CERTIFIED CHECKS, OR MONEY ORDERS ONLY. NO PERSONAL CHECKS. DEADLINE SEPT. 1<sup>ST</sup>. NO EXCEPTIONS WILL BE MADE.** Sorry- we have received too many checks with insufficient funds.

## LIABILITIES

It is the responsibility of the vendor to have appropriate liability insurance, seller's permits, health permit. Copies must accompany your application. None of the sponsoring organizations assume responsibility for any loss, damage, injury or claim arising out of the participant's acts of omission in the Bonitafest.

One space is 18' x 20', ½ space is 9x20 *Note: 1/2 SPACE WILL NOT ACCOMMODATE A 20'X20' CANOPY!*

**SPACE FEES: Deduct \$15 from booth fee for EARLY BIRD SPECIAL if received by JUNE 30<sup>th</sup> only. Not valid after June 30<sup>th</sup>, 2010.**
